**Fair Weather Growers Flower Share Responsibility**

- Provide flowers that meet high quality standards.
- Have flowers picked and ready for pick-up on the designated days and time.
- Post weekly newsletters every Friday.

**CSA Members Responsibility**

I understand that pick up is on **SUNDAY, TUESDAY** and **THURSDAY** only between 9:00AM-6:00PM, if I am unable to pick up my flowers, or find someone to pick up for me, I understand that my flowers will be forfeited at end of day Thursday and donated.

\*4 weeks (July 14 – Aug 8) - The **last pick up** will be on August 8th only from 9:00AM-6:00PM. Initial \_\_\_\_\_

\*4 weeks (Aug 11 – Sept 1) - The **last pick up** will be on September 5th only from 9:00AM-6:00PM. Initial \_\_\_\_\_

\*8 weeks (July 14 – Sept 1) – The **last pick up** will be on September 5th only from 9:00AM-6:00PM. Initial \_\_\_\_\_

Read the Weekly Newsletter, this is the primary way we communicate with all of our members; there is some very important information in it.

Understand that your payment entitles you to a weekly share of flowers and also the risk involved in agriculture. (Such as weather and crop failure)

Understand that as a member of the Flower CSA Share I share in that risk and accept unforeseen outcomes.

Flower examples: Anemone / Asters / Ageratan / Cosmos / Celosia / Gomphrenas / Zinnias / Snap Dragons / Lisianthus / Strawflowers / Sunflowers / Delphinium. Not limited to these flowers – just examples.
